## ANNOUNCEMENT

### ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE BALANCE 1Q FY23/24 DISTRIBUTION

Further to the announcement dated 25 July 2023 by Mapletree Logistics Trust Management Ltd., as manager of Mapletree Logistics Trust (“**MLT**”) (the “**Manager**”) in relation to the application of the distribution reinvestment plan (“**DRP**”) to MLT’s distribution for the period from 11 April 2023 to 30 June 2023 (the “**Balance 1Q FY23/24 Distribution**”), the Manager wishes to announce that the issue price of the new units in MLT (“**Units**”) to be issued under the DRP is S\$1.649 per Unit.

The issue price represents approximately 2%<sup>1</sup> discount to the adjusted volume-weighted average traded price<sup>2</sup> per Unit (“**adjusted VWAP**”) for all trades on Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) during the period of 10 Market Days<sup>3</sup> prior to and ending on the Record Date of **2 August 2023**.

The Notice of Election is expected to be despatched to all Eligible Unitholders<sup>4</sup> on **10 August 2023** for which an announcement will be issued accordingly.

<sup>1</sup> The issue price represents effectively approximately 3% discount to the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 Market Days prior to and ending on the Record Date.

<sup>2</sup> The adjusted VWAP is computed based on the volume-weighted average traded price per Unit for all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the Record Date and subtracting the Balance 1Q FY23/24 Distribution of 2.037 Singapore cents per Unit for each of the market days prior to the first day of “ex-distribution” trading.

<sup>3</sup> “Market Day” means a day on which the SGX-ST is open for trading in securities.

<sup>4</sup> “Eligible Unitholders” means persons registered as unitholders of MLT in the Depository Register as at 5.00 p.m. on the Record Date of 2 August 2023 and with registered mailing address in Singapore.
