COMPLETION OF DIVESTMENT OF 30 TUAS SOUTH AVENUE 8

Further to its press release dated 10 May 2024, Mapletree Logistics Trust Management Ltd., as Manager of Mapletree Logistics Trust ("MLT"), wishes to announce that the divestment of 30 Tuas South Avenue 8 in Singapore has been completed today.

Following this divestment, MLT's portfolio stands at 186 properties, comprising 48 properties in Singapore, 14 in Australia, 43 in China, 9 in Hong Kong SAR, 3 in India, 24 in Japan, 14 in Malaysia, 21 in South Korea and 10 in Vietnam. The total value of assets under management is S\$13.3 billion¹.
