On 15 November 2024, MLT has issued (1) 126,583 new units at S\$1.3340 per unit and 127,316 new units at S\$1.3317 per unit payable to MLTM as payment of acquisition fees; and (2) 6,722,370 new units payable to MLTM and 940,887 new units payable to Mapletree Property Management Pte. Ltd. ("MPM") at S\$1.4516 per unit as payment of base fee, property and lease management fees. Both MLTM and MPM have nominated Mulberry Pte. Ltd. to receive the aggregate of 7,663,257 new units as set out in item (2).
